As per the vide reference 1st cited above, Government has accorded permission for engaging two hundred and one (201) Tutors on contract basis to work in fourteen (14) Medical colleges, under the administrative control of DME for a period up to 31.03.2023 or till the actual need cease or till the regular posts are filled-up, whichever is earlier by paying the monthly remuneration of Rs.57,700/- which includes all perks paid through IFMIS-DBT mode.

The concerned Principals of the medical colleges are hereby instructed to engage the tutors on contract basis as through District Selection Committee following the latest guidelines in force issued by NMC.

As per the vide reference 3rd cited above, the Tutors are from Non-Medical qualification (M.Sc) only. The posts of Tutor are tenure positions not exceeding 3 years. The candidate must be below 45 years of age at the time of initial appointment. The qualifications and eligibility criteria for engaging the Tutors should be as per the Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022 by NMC. Dated: 14-02-2022. No tutor is allowed to continue after three years of tenure period.


